



_____ I agree to consign items for the purpose of resale, accepted by Femelle Bridal, for a period of 3 months. At the end of this contract, there will be a 2 week grace period allowing clients to pick up any unsold items, claim any monies due, or renew the contract upon the approval of Femelle Bridal.

_____ To meet consignment requirements, items must be in new, 'like new' and/or very 'gently used' condition, clean, pressed, generally odorless and no more than 3 years old (meaning items originated from the designer no more than 3 years ago), with exceptions to be made at the discretion of Femelle Bridal.

_____ Ideally, the original sales receipt for items will be presented to Femelle Bridal to help set the consigned price of items. The consignee and Femelle Bridal will agree upon the initial price of consigned items.

_____ We ask that potential consignors email photos, style number, designer, and original retail price of items, *prior* to setting up a potential appointment for inspection.

_____ After the first 60 days of the initial 3-month contract, Femelle Bridal may propose marking down any items to encourage sale, in addition to reductions from store-wide sales. The consignee and Femelle Bridal will agree upon reductions before markdowns occur.

_____ Femelle Bridal will issue checks for 50% of the selling price after the items have sold on the 1st and 15th of every month.

_____ If the consignee breaks this contract before the agreed 3-month period, there will be a \$75.00 fee per garment due at pick up, as compensation for having worked to sell your items..

_____ Femelle Bridal is a wedding attire broker and cannot hold insurance for inventory it does not own. We are careful and trustworthy, but assume NO liability for abandonment, theft, damage, fire, and or any shop wear. Should you have any concerns regarding valuable items, we encourage contacting your insurance agent.

_____ Please note: the consignor acknowledges that their item will be placed on consignment and tried on by potential brides. While we do our very best to keep items in great condition, we can not guarantee that your items will be in the same condition as when it was consigned. You are consigning at your own discretion.

_____ Unsold items must be picked up within 14 days of the contract termination date with a scheduled pick up appointment.
